You will also need to remember sometimes listening to a story is different than reading a story. NOW, let's start listening. Listen to the 1st 20 minutes of the podcast. Make sure to use the graphic organizer and answer the questions about connotations. Think about this, the words that we chose impact the meaning. Remember connotation is: an idea or feeling that a word invokes in addition to its literal or primary meaning. Exercise 3: Connotation

Questions

- 1. What does it mean when someone is "loosey-goosey" with details (8:09)? How is the denotation and connotation different from "lying" or "committing perjury"?
- 2. How is a "teeny weeny bag of marijuana" (6:58) different than "a small amount of drugs"?
- 3. What does the narrator mean when she says Adnan and his friends were "healthy American teenagers who were going to do what teenagers do, so long as they didn't get caught" (10:00)?
- 4. The state portrays Adnan as "duplicitous." Sarah and Saad phrase it differently: "We all grew up with that dual personality" that comes with being a "normal kid with immigrant parents" (10:00). What's the difference in denotation? What's the difference in connotation? Does this difference show up in your own life?
- 5. The narrator notes that Adnan was asleep when the cops arrested him and took him to the interrogation room (12:32). Why does this detail matter in an artistic sense? (What would be lost if she just started the scene in the interrogation room?)

- 6. The narrator describes Adnan as having "big brown eyes, like a dairy cow" (19:45). What is the connotative meaning of this?
- 7. Look at your answers to the previous questions in this section. What is the cumulative impact of the narrator's diction? In other words, can you detect a bias in her description, or a way that she wants the listener to react?

"Serial"

This section of the story also covers the first 20 minutes but if you did good note taking you might have what you need. Otherwise, you might be doing some replaying of various sections of the 1st 20 minutes.

For this section were calling "Lie Detector". Before Jay starts telling his version of the story to the police officers, Sara tells us that someone is lying (either Adnan or Jay) and then she specifically tells us that Jay changes his story several times.

Be a detective and based on your active listening and note taking skills piece together this puzzle from your perspective. Don't forget, someone's life is on the line.

Questions

Sarah: He's adamant about this. You can hear it, right? He's staunch. The problem is, when you ask Adnan to go back and tell his version of what happened that day, to refute Jay's story, everything becomes a lot mushier.

Getting Technical. If you took good notes on your graphic organizer you might not have must "re-listening" to do. You are going to diagram in google slides and submit through google classroom the timeline laid out during Episode 1. I have gotten as nitty gritty as 30 time stamps with important information or as broad as 10. You need to list 12 things using time stamps from youtube. They can either be plot related such as "Hook/introduction" "Climax" or perhaps when certain characters share their points of view, or "this is when we're fact checking Adnan's case at 8:09 to 9:00 minutes. Or Conclusion: Min 51 to the end and then describe the conclusion. Remember it must be on google slides. Adding in animation/color/graphics for bonus points are possible on this assignment.

You have now read a case based on a trial with various jurors, got to play part of the investigation into another court case and finally I want you to watch a clip from the film "A few good men" Here's a summary. Visit:

English 2 to watch this clip. You will have seen, heard, and watch pieces of various courtroom/trial action.

A brief summary of the film since you are only watching 5 minutes Of it: In this dramatic courtroom thriller, LT Daniel Kaffee, a Navy lawyer who has never seen the inside of the courtroom, defends two stubborn Marines who have been accused of murdering a colleague. Kaffee is known as being lazy and had arranged for a plea bargain. Downey's Aunt Ginny appoints Cmdr. Galloway to represent him. Also on the legal staff is LTJG Sam Weinberg. The team rounds up many facts and Kaffee is discovering that he is really cut out for trial work. The defense is originally based upon the fact that PFC Santiago, the victim, was given a "CODE RED". Santiago was basically a screw-up. At Gitmo, screw-ups aren't tolerated. Especially by Col. Nathan Jessup. In Cuba, Jessup and two senior officers try to give all the help they can, but Kaffee knows something's fishy. In the conclusion of the film, the fireworks are set off by a confrontation between Jessup and Kaffee.
